

MAGICAL VACATION CONTEST RULES

THE MAGICAL VACATION CONTEST (THE “**CONTEST**”) WILL BE CONDUCTED IN CANADA ONLY (EXCLUDING QUÉBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE “**CONTEST RULES**”).

1. ELIGIBILITY.

1.1 To be eligible for this Contest, an individual must:

- (a) be a legal resident of Canada (excluding the province of Québec);
- (b) be of the age of majority in his/her province or territory of residence or older at the time of entry; and
- (c) be legally able to travel to Orlando, Florida, and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.

1.2 The following people are not eligible to enter the Contest:

- (a) Employees of the Contest sponsor, Corus Sales Inc., its parent, officers, directors, affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies (collectively “**Corus**”);
- (b) Employees of The Walt Disney Company (Canada) Ltd., its officers, directors, affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies (collectively, “**Disney**”);
- (c) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below; and
- (d) The household members or immediate family members of any of the parties listed in Subsections (a) through (c) above.

1.3 Corus shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to Corus for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Corus reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. **CONTEST PERIOD.** The Contest begins at 10:00 a.m. Eastern Standard Time (“**EST**”) on January 13, 2019 and ends at 11:59 p.m. EST on February 10, 2019 (the “**Contest Period**”) after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter online by completing and submitting the entry form located at <https://www.disneychannel.ca/magical-vacation> (the “**Contest Microsite**”). No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per person, per 24-hour period. In the case of multiple entries in a 24-hour period, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of Corus and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, “authorized account holder” of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide Corus with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZE.

- 4.1 There is one (1) prize (the “**Prize**”) available to be won by the Prize winner (the “**Winner**”) and up to three (3) guests (each a “**Guest**” and collectively, the “**Guests**”) consisting of a five (5) nights and six (6) days’ vacation to the *Walt Disney World* Resort in Orlando, Florida (the “**Resort**”), which shall include:
 - (a) Up to four (4) round trip coach airfares for the Winner and Guests between the major Canadian International airport closest to the Winner's residence, as determined by Disney, and Orlando International Airport (the “**Arrival Airport**”);
 - (b) Up to four (4) round trip ground transfers for the Winner and Guests between the Arrival Airport and the Resort, as determined by Disney in its sole discretion;
 - (c) Five (5) consecutive nights’ hotel accommodation in the Resort at a hotel to be selected by Disney in its sole discretion, for the Winner and Guests, in a standard room based on quadruple occupancy unless otherwise indicated;
 - (d) Up to four (4) 6-Day *Walt Disney World* theme park tickets with *Park Hopper Plus* option;
 - (e) One (1) Disney gift card with a value of six hundred U.S. Dollars (USD\$600.00); and
 - (f) Services of one (1) Disney VIP Tour Guide at the Resort, for eight (8) hours on one (1) day during the vacation.
- 4.2 The Prize has an estimated retail value of eleven thousand nine hundred U.S. dollars (USD\$11,900.00). Actual value of Prize will depend on departure city.

- 4.3 Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 Corus and/or Corus' representatives will contact the Winner to coordinate the provision of the Prize within five (5) days once such Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking and must be made at least forty-five (45) days prior to the intended travel date. All reservations are subject to the terms and conditions set out on Disney's website located at <https://disneyworld.disney.go.com/tickets/>. Blockout dates may apply. Winner and his/her Guests must be available to travel and participate in the Prize between April 1, 2019 and October 1, 2019. Should Winner and/or Guest be unable to travel/participate on the dates and times designated by Corus and Disney, the Prize will be forfeited and awarded to an alternate winner.
- 5.2 The terms by which the Disney gift card may be redeemed are governed by Disney as described on the website located at <https://www.disneygiftcard.com/ProductInformation/WhereToUse>. Corus is not responsible for administering or ensuring compliance with the terms and conditions relating to the gift card.
- 5.3 Winner and Guests will be responsible for transportation to and from originating airport, travel and medical insurance, travel documentation, airport improvement fees, airlines baggage fees, taxes, tips and gratuities, local and long distance telephone calls, in-room charges, meals, beverages, nursery charges, merchandise, souvenirs, parking, and any other expense not explicitly included in the Prize. Winner may be required to present a valid major credit card upon check-in at the hotel to cover any expenses over and above the standard room charge.
- 5.4 Guests must: (i) be legally able to travel to Orlando, Florida and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (ii) comply with the Contest Rules and sign and return the Release (described in Section 7 below).
- 5.5 Prize must be accepted as awarded and cannot be sold, traded, transferred, refunded, commissioned, assigned, substituted or redeemed for cash or rescheduled to dates other than as set forth above, except at the sole discretion of Corus and Disney. Any unused, unclaimed or declined portion of the Prize will be forfeited, have no cash value, and Corus and Disney shall have no obligation to provide either an alternative or value-in-kind. Corus and Disney reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- 5.6 Shipped Prizes shall not be insured, and neither Corus nor Disney shall assume any liability for lost, damaged or misdirected Prizes.
- 5.7 All disputes arising out of or relating to the Prize provided by Disney shall be resolved by applying the law of Florida, without regard to conflict of law rules, and shall be solely and exclusively brought in state or in federal courts within Orange County, Florida. Such claims shall be resolved individually, without resort to any form or class action and all such claims shall be limited to actual out-of-pocket costs incurred, but in no event to include any attorneys' fees.

6. WINNER SELECTION.

6.1 One (1) Winner shall be selected as follows:

- (a) On or about February 12, 2019 at 2:00 p.m. EST in Toronto, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. The odds of being selected as a potential Winner are dependent upon the number of eligible entries received by Corus. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release.
- (b) **THE SELECTED ENTRANT WILL BE NOTIFIED BY E-MAIL NO LATER THAN FEBRUARY 15, 2019 AT 5:00 P.M. EST AND MUST RESPOND WITHIN FIVE (5) BUSINESS DAYS OF NOTIFICATION.** Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive the Prize and another entrant may be selected in Corus' sole discretion until such time as an entrant satisfies the terms set out herein. Corus is not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for Corus to receive a selected entrant's response.
- (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

7. **RELEASE.** Potential Winner and Guests will be required to execute a legal agreement and release (“**Release**”) that confirms potential Winner's and Guests': (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of Corus, Disney, and their respective employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, prize providers, advertising, media buying and promotional agencies (collectively, the “**Releasees**”) from any and all liability for any loss, harm, damages, costs or expenses arising out of participation in the Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) grant to Corus of the unrestricted right, in Corus' discretion, to produce, reproduce, display, publish, post, serve, broadcast, exhibit, distribute, adapt and otherwise use or re-use Winner's and each Guest's name, statements, image, likeness, voice and biography, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within two (2) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

8. **INDEMNIFICATION BY ENTRANT.** By entering the Contest, each entrant releases and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from: (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to

fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.

9. LIMITATION OF LIABILITY. Corus assumes no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. Corus is not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. Corus assumes no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of Corus, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest, and/or the Contest Microsite.

10. CONDUCT. By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Microsite and made available throughout the Contest Period. Each entrant further agrees to be bound by the decisions of Corus, which shall be final and binding in all respects. Corus reserves the right, in its sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest, and/or the Contest Microsite or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass Corus or any other person. **CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE THE CONTEST MICROSITE OR ANY RELATED WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, CORUS RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING BUT NOT LIMITED TO CRIMINAL PROSECUTION.** Winner and Guests must at all times behave appropriately when taking part in the Prize and comply with the Contest Rules and any other rules or regulations in force at the Resort and/or any other Prize-related locations. Corus and/or Disney reserve the right to remove from the Resort and/or any other Prize-related locations, any Winner and/or Guest who breaks such rules and/or fails to behave appropriately and to disqualify such Winner and/or Guest. Any disqualified Winner and/or Guest will forfeit any un-awarded elements of the Prize.

11. PRIVACY / USE OF PERSONAL INFORMATION.

11.1 By participating in the Contest, each entrant: (i) grants to Corus the right to use his/her name, mailing address, age of majority confirmation, telephone number and e-mail address (collectively the "**Personal Information**") for the purpose of administering the Contest, including but not limited to contacting and announcing the Winner and coordinating the provision of the Prize; (ii) grants to Corus the right to use his/her Personal Information for publicity and promotional purposes relating to the Contest, in any and all media now known or hereafter devised, without further compensation unless prohibited by law; and (iii) acknowledges that Corus may disclose his/her Personal Information to third-party agents and service providers of Corus, and Disney as the Prize provider for this Contest for the sole purpose of Prize fulfillment, in connection with any of the activities listed in (i) and (ii) above.

11.2 By opting-in you consent to Corus using your Personal Information to contact you with exclusive offers, announcements, and other promotions.

11.3 Corus will use the entrant's Personal Information only for identified purposes, and protect the entrant's Personal Information in a manner that is consistent with the Corus Privacy Policy at: <https://www.corusent.com/privacy-policy/>.

12. INTELLECTUAL PROPERTY. All intellectual property, including but not limited to trade-marks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, slogans and representations are the property of their respective owners. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

13. TERMINATION. Corus reserves the right, in its sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.

14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over Corus. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and Corus in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.

15. DISCREPANCY. In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.

16. SOCIAL MEDIA. This Contest is in no way sponsored, endorsed or administered by any social media platforms on which the Contest may have been promoted and/or publicized, including but not limited to Facebook, Instagram and/or Twitter. Any personal information provided in connection with the Contest is being provided to Corus and any questions, comments or complaints regarding the Contest must be directed to Corus.
